GOVERNMENT FEES & TAXES INCREASE

Please be advised that the Government Fees & Taxes for your voyage have been adjusted by an additional \$30.47 per person effective for bookings made prior to March 18, 2010. For bookings paid in full, no action is required. This amount will automatically be charged to your shipboard account. For bookings not paid in full, the Government Fees & Taxes have been adjusted accordingly, and the balance due has changed. Please review the balance due amount prior to making final payment.

FUEL SUPPLEMENT

Because of the escalation of fuel prices, Cunard Line has announced a fuel supplement for all bookings made on or after May 10, 2010, for all voyages departing on or after November 1, 2010. The fuel supplement for your client's voyage will be USD \$3.85 per person, per day (not to exceed USD \$154 per person) and will be automatically added to your client's booking. The fuel supplement is necessitated by significant rises in fuel prices which previously have been absorbed by Cunard Line. Unfortunately it is no longer possible to cover these significant expenses.
