PLEASE CALL WITH FINAL PASSENGER COUNT BY 3:00PM THE DAY PRIOR TO DEPARTURE OR BY 3:00PM ON FRIDAY PRIOR TO WEEKEND OR MONDAY TRAVEL. ADDITIONAL PASSENGERS ARE BASED ON CURRENT AVAILABILITY. ONCE FINAL COUNT IS GIVEN ALL NO-SHOWS FOR BOAT AND TOURS ARE NON-REFUNDABLE.

A 100% refund will be given if a departure is cancelled due to weather or any other circumstances as determined by the Catalina Channel Express. **If deposits are not received according to the above schedule, it is assumed the group wishes to cancel and deposits being held will be refunded automatically according to the above cancellation policy.**

Travel and baggage restrictions apply to all passengers. **U.S. Coast Guard regulations prohibit any flammables aboard passenger vessels.** Refer to the company brochure or ask the sales representative.

Group rates are offered on a limited basis to any group booking a minimum of 20 adults traveling together round-trip. This minimum must be maintained for group rates to apply. If any group member(s) breakaway from group on return, they will forfeit group return ticket and must purchase new full fare one-way ticket. Cannot be combined with any other offer or discount.

Chaperons: All student groups under 18 years of age must have at least one chaperon for every 10 students. Each group must assign a representative to act as a liaison between the Catalina Express staff and their group. The representative will be responsible for all check-in and ticketing procedures. A passenger manifest must be presented to the ticket window on the day of travel. Please designate adults from children.

Check-in: The Catalina Channel Express maintains a 1-hour check-in prior to departure. Stand-by passengers are taken at 15 minutes prior to departure. Please be advised that a California Utilities Commission approved fuel surcharge may need to be collected on the day of departure.
